VENUE FOR 2002

Prof. Ramesh K. Kakar extended an invitation to the Society to hold its next Annual General Meeting at the Centre of Advanced Study in Geology, Punjab University, Chandigarh. The invitation was accepted by the General Body.

WORKSHOP ON RAINWATER HARVESTING

As part of the programme of the Annual General Meeting, a National Workshop on Water Harvesting with special reference to Artificial Recharge was held on the 9th and 10th October 2001.

In his presidential remarks Dr. B.P. Radhakrishna, President of the Geological Society of India emphasized the need to have a blue print of action for sustained development of groundwater resources. He particularly commended the work of crusaders like Annasaheb Hazare and Rajendra Singh of Tarun Bharat Sangh who have achieved success in transforming barren land into garden land through better water management.

Sri S.K.Tripathi, Secretary, Ministry of Rural Development, Govt. of India, in his inaugural address

stressed the need for water harvesting. He referred to the Model Bill for regulation and control of groundwater circulated by the Ministry of Water Resources for adoption. He listed various central projects and programmes oriented towards water resource development.

Dr.Y.J. Parthasarathy, Regional Director, C.G.W.B. offered a few remarks on aspects of augmentation of groundwater resources. There were several presentations reviewing current water harvesting practices in different geo-environs, effectiveness of water harvesting, revival of traditional harvesting systems, prioritization of approaches, urban water harvesting, groundwater legislation and research and development needs.

The interesting part of the workshop was the presentation made by grassroot level workers, Hardev Singh Jadeja, Sarpanch Raj-Samadhiyala, Rajkot, Gujarat, who by leading the people of his villages in the programme implementation of water harvesting brought spectacular socio-economic transformation.

Rajendra Singh, the recipient of the Magsaysay Award for the year 2001, gave an account of the traditional watershed development practice in Rajasthan, transforming dry inhospitable land to a green garden land with increased bio-mass productivity/fodder availability, increased microenterprenureships which created surplus food grain, milk, milk products, better impact on health and hygiene due to increased water availability. Rajendra Singh has become a modern Bhagirath in rejuvenating dried up river beds. President of the Society garlanded Rajendra Singh and decorated him with a shawl in token of appreciation of the great work he has been doing in enthusing rural community in the development of natural resources.

Anupam Mishra, Director, Gandhi Peace Mission, provided a visual feast with his excellent colour slides taking the audience on a visual tour of the traditional water harvesting structures of Jaisalmer area in the heart of Rajasthan desert. Ramaswamy Iyer, formerly of Centre for Policy Research, New Delhi, gave a fine summary of aspects of groundwater legislation and stressed the need for the Karnataka State to hold water resource in trust on behalf of the community.

Ganga Gaatha, a dance drama depicting the descent of divine river Ganga to the earth enchanted the audience with a most elegant performance.

With a vote of thanks to D. Muralidharan and his teammates for the excellent arrangements made for holding the AGM and the Workshop on Water Harvesting, the curtain on yet another AGM of the Society came down.
